**Tuition Policies:**

Tuition is based upon the selected enrollment option. A current tuition rate schedule is attached. Tuition is separate for our two sessions: a nine-month academic school-year session (mid August through May), and a separate summer session (June through mid August). You may pay the tuition in full or in monthly installments due on the first day of each month. There is no tuition reduction for scheduled closures, unscheduled shutdowns due to hazardous or weather related conditions, or holidays since the tuition is fixed for the full session. The school cannot give refunds or credit for absences since the school's disbursements are unaffected by such. However, we reserve the right to make exceptions under extenuating circumstances, such as unexpected medical conditions of a serious and prolonged nature.

Tuition payment is due on or before the first day of each month. Please make checks payable to Bilingual Montessori School, LLC. Please keep the invoice as your tax record and record the invoice number on your check. And either mail or deliver to the school by the first of the month. There will be a \$50 charge for any check returned by the bank unpaid.

BMS provides a 10% tuition discount for siblings of existing students living at the same residence.

**Tuition Payments Due Date**

Payments are due on the 1st day of every month. Any payment after the fifth of the month is considered late, regardless of which day of the week the 5th falls on. Late payments trigger a \$50 late fee.

If you sign up for Extended Care you will be charged for the secured dates and times whether your child is in attendance during this time or not.

If your child is attending an extracurricular activity conducted at BMS during Extended Care hours, you will be charged the Extended Care fee, separate from the activity's teacher fee. If the extracurricular activity occurs during Basic Program hours, there is no rebate for the time spent in the extracurricular activity. (This holds true ONLY for the dates that school is in session.)

Child must be present during the Basic Program hours any day when Extended Care is used.

### Admission Policies:

Waiting List: Names will be placed on waiting lists for each program, and granted enrollment on a first-come, first-served basis. Children are assigned to the appropriate program with consideration to Montessori experience, sex, and age.

The emotional and physical well being of all children at all times is the foundation of a Montessori classroom. All children are enrolled at BMS on a provisional basis. It is possible that a particular child will not adjust or be suited to the Montessori environment. If this occurs, and if in the judgment of the Teacher or the Director, the child is not benefiting from the Montessori experience, and/or is interfering with the class functions, the parent may be instructed to withdraw the child, without financial obligations thereafter.
